## Glenmore Village Car Park Conditions of Entry



ATTENTION ALL PERSONS entering the Glenmore Village Car Park.

The following conditions apply when you enter, leave or use the Car Park. If you do not accept these conditions, please immediately leave the car park. If you are in a vehicle and are unable to turn it around you may, subject to these conditions, proceed directly to the nearest exit.

You enter and use the Car Park at your own risk. We may refuse entry by any vehicles or persons.

We are not liable to you or to any person with you for:

- a) injury to you or anybody else
- b) damage to, destruction of or theft of the vehicle or property.

You agree to indemnify us in respect of any claim made against us and any expenses incurred by us as a consequence of, in relation to, or in any way arising out of your use of this car park.

You agree to:

- a) park in the designated parking space
- b) not use this Car Park other than in the accordance with instructions we may give.
- c) observe all car parking height restrictions.
- d) not to park a vehicle greater than 2004 B99 vehicle PROHIBITED inside the basement carpark.

While in the car park, you must comply with all signs and all reasonable directions and requests made by us. We are not liable for any damage caused to your vehicle's window. We are not liable for any damage caused to your vehicle when an adhesive car parking infringement is applied to your vehicle. We have the right, at our discretion, to move your vehicle (including moving it to any location outside this car park), even if your vehicle is locked. If we move your vehicle, these conditions continue to apply. We are not liable for any damage caused to your vehicle when we move it.

These conditions may only be altered by a written agreement between you and us.

If any of these conditions are illegal or unenforceable, the offending part is to be disregarded and does not affect the remaining part.

Each exclusion of our liability in these conditions is subject to any law which restricts or forbids that exclusion of liability including the Trade Practices Act and similar State legislations.

Towed vehicles or equipment are prohibited to be left on site unoccupied from the primary towing vehicle.

Vehicles should not be parked in the car park for longer than 2 hours and are not to be left in the car park overnight without the building owner's consent. Vehicles left in the car park over 24 hours will be removed at the vehicle owner's cost.

Service or maintenance of all vehicle or towing equipment is strictly prohibited in the car park.

In these conditions references to:

- a) "we", "us" and "our" mean Glenmore Village Shopping Centre, it's employees, agents and independent contractors
- b) "your vehicle" includes a vehicle driven, or intended to be driven, by you in this Car Park.

Glenmore Village Centre is a SMOKE FREE area. Smoking and the use of e-cigarettes is prohibited in the Centre car parks.
